THIS PROGRAM HAS TWO MAJOR COMPONENTS: TRANSITIONAL HOUSING AND EDUCATIONAL/VOCATIONAL TRAINING. OUR TRANSITIONAL HOUSING PROGRAM PROVIDES HOUSING, CASE MANAGEMENT, AND HOLISTIC CARE FOR 4 WOMEN FOR UP TO 12 MONTHS. WE ALSO OFFER RESTORE, WHICH IS A VOCATIONAL/EDUCATIONAL TRAINING PROGRAM. THROUGH BOTH PROGRAMS, WE FOCUS ON MENTAL AND PHYSICAL HEALTH, EMPLOYMENT, FINANCIAL STABILITY, EDUCATION, SOCIAL CONNECTEDNESS, TRANSPORTATION, AND CONNECTION TO COMMUNITY RESOURCES. THROUGH THIS, SURVIVORS ARE EMPOWERED TO LIVE INDEPENDENT AND SUSTAINABLE LIVES. SEE SCHEDULE "O" FOR 2021 ACCOMPLISHMENTS.
